COVID-19 Relief: American Rescue Plan


- \$1.9 trillion total
 - \$20B for national vaccination program
 - \$15B for a new grant program for small business owners
 - \$35B for small business financing
 - \$3B for the Economic Development Administration
 - \$350B for state and local governments

| HB 2521 | Requires transient lodging tax collector to provide invoice, receipt or other similar document that clearly sets forth sum of all transient lodging taxes charged for occupancy of transient lodging. | Rep. Marsh | Revenue |
| HB 2579 | Increases state transient lodging tax rate to 1.8% and provides for transfer of moneys attributable to increase to county in which taxes were collected. Requires transferred moneys to be used exclusively for affordable housing in county. | Rep. Pham & Sen. Dembrow | Housing |
| HB 2600 | Provides that stated percentage of revenue from state transient lodging tax (.025%) be transferred to Oregon Conservation and Recreation Fund. Repeals sunset of Oregon Conservation and Recreation Fund. | Reps Helm, Lively, Power, Reardon, Wilde, Witt; Senators Dembrow, Fendrick, Prozanski | Revenue |
| HB 2672 | Establishes Ocean Beach Fund. Directs amount of transient lodging tax revenues from state recreation area lodgings along ocean shore received by State Parks and Recreation Department to Ocean Beach Fund. Directs department to spend moneys from fund for expenses of managing state recreation areas along ocean shore. | Rep Smith DB | Revenue |
| SB 102 | Exempts from state and local transient lodging taxes military lodging used for temporary overnight human occupancy by active or retired members or service veterans of Armed Forces of the United States or National Guard or by employees or agents of Oregon Military Department. | Presession filed at request of Gov. Brown for Oregon Military Department | Veterans and Emergency Preparedness |

| SB 395 | Increases required expenditure on footpaths and bicycle trails from one percent to five percent of amounts received from State Highway Fund. | Sen Prozanski (at request of The Street Trust) | Transportation |
