

DESTINATION READY BACKGROUND

- In 2020, Oregon's communities were significantly impacted by COVID-19, wildfires and social unrest.
- To address these challenges, Travel Oregon launched the Destination Ready program in 2021 to support the development, enhancement and stewardship of key visitor experiences focusing on destination recovery and resilience.
- In 2021, Travel Oregon launched Destination Ready 2.0, continuing efforts to strengthen visitor experiences and build long-term resilience.
- Through the program, Travel Oregon staff and expert consultants partnered with awarded communities to conduct data-informed destination assessments, identifying short-and-medium-term priority projects to strengthen key visitor lures.
- Communities that completed the program became eligible for project implementation support, technical assistance and funding.




PROJECT OUTCOMES: OREGON OUTDOOR RECREATION MAPS

With the addition of four new Outdoor Recreation Maps, Travel Oregon now features 11 destinations across the state. 5. DOLLAR MOUNTAIN TRAIL SYSTEM DEVELOPMENT

Design a 15-mile high-quality, mountain bike and hiking trail system to boost accessible outdoor recreation, tourism and economic impact in Grants Pass, offering a valuable recreational asset for both residents and visitors.



PROJECT OUTCOMES: DOLLAR MOUNTAIN TRAIL SYSTEM DEVELOPMENT

With trail design complete, Grants Parks & Recreation Department applied for and received a \$350,000 grant from Oregon State Parks Local Government Grant Program to fund trail construction and a new parking lot in 2024.

Not only is the trail system largely in support by residents (78% according to a 2020 survey), but it also supports the city's fuel-reduction (fire mitigation), eco-tourism and economic development, and accessible recreation improvement goals.

6. HELLS CANYON SCENIC BYWAY ACCESSIBILITY ASSESSMENT

Conduct an accessibility assessment of 15 visitor-facing locations along the Hells Canyon Scenic Byway, including lodging, restaurants, art galleries, visitor centers, and outdoor recreation sites, to better understand the barriers disabled travelers may encounter and ways to improve their experience.

Hells Canyon Overlook: This is one of the most wheelchair accessible outdoor sites along the entire Byway. There are paved paths, accessible picnic tables, and accessible vault toilets.

However, there is no designated accessible parking.

PROJECT OUTCOMES: HELLS CANYON SCENIC BYWAY ACCESSIBILITY ASSESSMENT

With the initial accessibility assessment complete, the Eastern Oregon Visitors Association input all the visitor-facing site information into Blue-Path.org, a non-profit that provides consumers with disabilities detailed accessibility information, enabling them to navigate more effectively and informed.

Building from the momentum, Umatilla Tourism and Wallowa County Chamber of Commerce were awarded \$65,900 Travel Oregon Competitive Grants in 2023 to offer destination accessibility workshops, conduct further assessments, and input more visitor-facing information on Blue-Path.org. This initiative enhances the quality and availability of accessibility-related information for visitors across more Eastern Oregon counties.

9. PANTHER CREEK MOUNTAIN BIKE TRAIL SYSTEM DEVELOPMENT

Develop a 25-mile bike-optimized trail system to boost accessible outdoor recreation, tourism and economic impact in Yamhill County, diversifying the visitor offerings and creating a valuable recreational asset for both residents and visitors.



PROJECT OUTCOMES: PANTHER CREEK MOUNTAIN BIKE TRAIL SYSTEM DEVELOPMENT

With trail design, flagging and preliminary work for an environmental assessment underway, Cycle Yamhill County continued outreach and fundraising, gaining support from Senator Merkley, as chair of a key Senate Appropriations subcommittee, writing the project into the fiscal year 2025 Interior-Environment spending bill:

"\$3.096 million to the Bureau of Land Management (BLM), in partnership with Cycle Yamhill County, for the construction of the Panther Creek Trail Network. The funding will be used to construct nearly 25 miles of world-class mountain bike trails on BLM-managed forestland in Yamhill County, creating recreational opportunities for community members and providing a boost to the regional economy."

12. YAMHILL RIVERS ACCESS STRATEGY ANALYSIS

Perform a comprehensive assessment of existing public access points along the Yamhill Rivers to identify key access opportunities, decrease the use of social trails and undeveloped access points, and reduce negative impacts to riparian ecosystems. The development of strategy is aimed at further enhancing Yamhill Rivers' communities as a destination and increasing the economic vitality of the region.

PROJECT OUTCOMES: YAMHILL RIVERS ACCESS STRATEGY ANALYSIS

With robust community engagement and buy-in of the municipalities, county and Oregon Marine Board, the Yamhill Rivers Access Steering Committee applied and was awarded the National Park Service-Rivers, Trails & Conservation Assistance Program in 2024. The program assists local communities over the course of 1-2 years in realizing their conservation and outdoor recreation vision and goals by providing a broad range of services and skills.

With the technical assistance of National Park Service, the Yamhill Rivers Access Strategy will continue building momentum in forming an Action Committee focused on outreach, action and implementation of the Yamhill Rivers Public Access Plan.
